- I (we) agree to pay to EJ Water Cooperative, Inc., at P.O. Box 8, Dieterich, IL 62424, an advanced connection fee in the amount of \$500.00 to be paid upon the execution of this contract. I understand that cleanup is not included in this cost and cleanup will be at my own expense.
- I (we) agree to become a customer of the system as soon as service is available to the above property and to pay the charges required by the rules, rates and regulations of the governing board, **including the monthly minimum once the water is installed.**
- I (we) understand that I (we) are required to install an expansion tank.
- I (we) understand there will be additional costs if a larger meter is necessary.
- I (we) further agree, as a condition of obtaining water service to grant to EJ Water Cooperative, Inc., an easement across the above property as may be necessary for the construction, operation, and maintenance of the water line.
- In the event I (we) breach this contract by refusing or failing, without just cause, to connect to the system or pay the minimum monthly rate, I (we) understand that I (we) forfeit the entire cost of the project.
- I (we) further understand that unpaid bills shall constitute a lien upon my real estate, and legal action can be pursued to collect the delinquent charges.
- In the event this membership is transferred to another party, I (we) understand there is a processing fee as set by the Board of EJ Water.
